The National Culturally and Linguistically Appropriate Services (CLAS) Standards from the Department of Health and Human Services' Office of Minority Health establishes 15 action steps for health care organizations to use to improve quality, advance health equity and reduce health disparities by providing culturally and linguistically appropriate health services. This resource outlines the CLAS Standards and provides guidance for implementation.
