ISSUE BRIEFS AND REPORTS ----

The Office of the Assistant Secretary for Planning and Evaluation wrote a report to Congress in December 2016 titled **Social Risk Factors and Performance under Medicare's Value Based Purchasing Program.** This report analyzes Medicare data to address the alignment of payments and intended goals of value-based purchasing programs. It provides considerations for policymakers while additional work using other data sources continues.

The CMS Office of Minority Health developed an issue brief, **Increasing the Physical Accessibility of Health Care Facilities**, which provides an overview of laws enacted to promote accessibility. It discusses examples of federal and state-level efforts to increase accessibility. The report offers suggestions for health care facilities to improve their physical accessibility on a broader scale.

ACADEMIC JOURNAL ARTICLES

The American Journal of Public Health published an article in September 2015, by Krahn et al., on **Persons with Disabilities as an Unrecognized Health Disparity Population.** The study reviewed evidence and found that the observed differences in this population are sufficient to meet criteria for health disparity status. The findings of this analysis could have impact on future research and policy directions.

The Annals of Internal Medicine published an article in March 2013 titled **Access to Subspecialty Care for Patients with Mobility Impairment: A Survey**. The study used a telephone survey to learn about the accessibility of medical and surgical subspecialist practices for patients with mobility impairment. The findings suggests that better awareness of ADA standards of care for patients in wheelchairs is needed.

The journal of Disability and Rehabilitation published a study in December 2016 titled **Understanding disability and the 'social determinants of health': How does disability affect peoples' social determinants of health?** The study investigated how an individual's social determinants of health are affected by the acquisition of physical disability in adulthood and report the described facilitators and barriers to living with a disability.

The National Academies of Sciences, Engineering and Medicine published an article in 2016 titled **Accounting for Social Risk Factors in Medicare Payment: Identifying Social Risk Factors**. The article is the first in a series of five reports that aim to provide input into whether socioeconomic status (SES) and other social risk factors could be accounted for in Medicare payment and quality programs.
